MINUTES OF THE MEETING OF DEPARTMENTAL SELECTION COMMITTEE HELD ON 22-09-2015 REGARDING APPOINTMENT OF CHILDREN OF RETIRED EMPLOYEES OF THE SCIENCE & TECHNOLOGY AND INFORMATION TECHNOLOGY DEPARTMENT.

A meeting of Departmental Selection Committee for appointment as Naib Qasid in the ST&IT Department was held under the Chairmanship of Deputy Secretary (Admn) on 22-09-2015 at 1400 hours in his Office. The following attended the meeting:-

2. The Chair welcomed the participants and briefed the Committee about the purpose of the meeting. The following agenda was placed before the Committee for consideration of appropriate decision.

**Item No. 1** Appointment of Naib Qasid against Retired Employees Son Quota.

- 1) The chair informed the Committee that Mr. Niaz Badshah Naib Qasid has been working since 21-11-2014 in the ST&IT Department (posted by Transfer). On his superannuation he retired from service on 30-08-2015. Consequently the post of Naib Qasid became vacant. Niaz Badshah (Retired N/Q) submitted an application for appointment of his son Mr. Imran Khan as Naib Qasid against the 25% reserved quota of retired employees son.
- 2) On the other hand, one Mr. Zarshad Chawkidar, ST&IT Department working since 01-11-2007 submitted an application for conversion of his post from Chawkidar to Naib Qasid under the 50% quota reserved for Farash, Mali, chawkidar, Gate messenger etc. The Committee decided that he will be considered for conversion only after appointment of three Naib Qasid in initial recruitment quota.
- 3) The representative of the Administration Department observed that total sanctioned posts of Class-IV in the ST&IT are 14. Out of these 14 posts, 7 posts go to the share of Initial Recruitment and 7 posts go to the share of By Transfer. The 25% share of retired class-IV employees son is two (2) posts. Mr. Shahzeb Naib Qasid had been appointed against the retired

has become vacant against the reserved quota of retired employees son.

**DECISION:**

The Committee unanimously decided that Mr. Imran Khan S/O Mr. Niaz Badshah (retired Naib Qasid) may be appointed against the vacant Post of Naib Qasid (BPS3) under the Employees Son Quota on regular basis with immediate effect.
