NO.SOG/ST&IT/KP/General/9-1/2022/ In pursuance of this Department's Notification No.SO(G)/ST&IT/NWFP/9-23/06/1191, dated 13-02-2008, Science and Technology and Information Technology Department in compliance with the decision of Caretaker Provincial Cabinet, Khyber Pakhtunkhwa during its meeting held on 9th August 2023 and after due consultation with Law, Parliamentary Affairs and Human Rights Department and Administration Department, Govt. of Khyber Pakhtunkhwa is pleased to revise the existing Internet Policy for the provision of internet connections to all the Ministers/Advisors, Officer of Civil Secretariat, Heads of the Attached Department, and officers in District Administration. The facility will be subject to the following terms and conditions:

- The internet connection shall be provided at the residences of all the Ministers/Advisors, Officers of the Civil Secretariat, Heads of Attached Departments and officers in District Administration in BPS-20 and above @ Rs.3500 per month, having with at least the capacity of 4Mbps.
- The officers in BPS-17 and above shall be provided an internet connection at their offices up to Rs.3500/month having at least the capacity of 4Mbps.
- The internet payment shall be adjusted beyond the telephone limit/ceiling of the Officers.
- The subject facility can be obtained from the market at competitive rates after following the due process.
- All the rest houses and Government houses of Khyber Pakhtunkhwa shall be provided with internet facilities from now onwards.
